## **President's Note**

Years ago when I first started working on my first patent, I received direction that now is completely invalid. Believe it or not I mailed a letter to myself explaining my idea along with the signatures of a couple of my friends who could verify the date. I used two people because I believe in "over-kill" and if I would need to go to court, I could hit my opponent with double barrels. I also bought a bookkeeper's "bound" book with numbered pages so I could track my every step. I would even draw diagonal lines through a page I didn't finish. This, of course, was when the U. S. Patent Office issued patents to "the first to invent", and I wanted to make sure I had my ducks in a row. Well since the United States has now joined other countries in granting patents to "the first to file" everything I had done then is worthless. I still keep that letter, though, as a reminder of how I need to be vigilant of changes that can occur and change my direction. I actually like that part of the America Invents Act of first to file, because now you don't have to worry about someone stealing your idea. That is, unless you share it with someone who files before you do. But that is where I like to emphasize how good it is to file a Provisional Patent Application. Since you can file it yourself at www.uspto.gov it is relatively easy to protect yourself and eliminate the worry. OK, I will confess that my mother always called me a "worry wart" (whatever that means) but I would tell her "an ounce of prevention is worth a pound of cure". And that brings me to why I shared this thought this month.

In reviewing a lot of correspondence, books, and magazines on inventing, I noticed a lot of articles had been written explaining the way to secure your idea back in the old days. The thought hit me that the writers had to get their article published so they could reap the benefits of their writings. Had they held back trying to perfect the wording, making everything perfect, their idea would be outdated and worthless before it reached press. That is the same thing that can happen to an inventor who spends too much time trying to perfect an idea instead of getting it out there for the customer to help develop it. OK, those who know me will say, "here it comes", and yes, get something made and "sell it to someone other than your mother". This will not only give you the assurance that you have an idea someone will want, but you will get feedback on how to perfect it and develop those ideosyncrasies that make your idea unique. Now you can move your product along a lot faster before another product takes the country by storm. So, get that idea of the "bar napkin", put it on paper with dimensions, do the design, and start going. With a provisional application filed, you can share your product with anyone that you need to get it to market. The best thing is, you're on a roll, and that is the best way to get things done.
