President's Note

As a member of the newly formed Inventors Association Leadership Circle, each month, I will brief you on what we talked about at the previous meeting.

It was a a round table conversation, moderated by Stephen Key. Our group is in search of anyone who leads an inventor's group and might benefit from participating in these discussions.

Stephen Key reminded the group about the questionnaire that Steve Lyon sent and Kris Paul contributed to. The questions are designed to help us see what everybody else is doing and to find out what the different groups look like. most pertinent items covered in the meeting were:

A brief discussion about what makes a great idea.

- o "If one day you are using two hands to do it and the next day you are only using one hand, you have a patent."
- Jeffrey Dobkin: "How do you know if you have a good product? Go sell one! If people take their wallet out, you have a good product. Your idea has to be commercially feasible."
- o Don Skaggs: "I'm not the one who is going to tell you if you have a great idea. The person who will do that is your customer!"
- o Warren Tuttle: "Does your product solve a big enough problem for enough people to make it commercially successful? If you really want to make money licensing, you have to sell a lot of units. Niche products are a different approach to market, where you can sometimes do it yourself and keep the margins high. To make a million dollars you can sell a million units at \$1 apiece, or you can sell one unit for a \$1MM." For licensing, the former is better than the latter.

Adrian mentioned that <u>a rally is planned for November 27th in front of the Supreme Court</u> to protest a controversial PTAB desicion. You can <u>read more about it from IPWatchdog</u>.

- o Kris has volunteered to go and to take people to the protest. It's on the Monday after Thanksgiving.
- o Charlie has also recommended writing Op-eds or letters to the editor and he has offered help write them, edit them, and place them. He also offered to help get any willing leader on radio interviews. Public exposure is important.
 - o Warren recommended drafting a template that everyone could use.

George Burkhardt, President of the <u>Alamo Inventors</u> group, had some very interesting and important information regarding the tax code and the treatment of royalties in exchange for patent rights as long term capital gains.

- o This information is in section <u>1235</u> the <u>United States Code</u>, <u>2006 Edition</u>, <u>Supplement 5</u>, <u>Title 26 INTERNAL REVENUE CODE</u>. This <u>PDF</u> is on the US GPO website.
- o It is also mentioned in chapter 15 of the book <u>Patent It Yourself</u> and in the book <u>What Every Inventor</u> Needs To Know About Business & Taxes.
