During our last two regular meetings we had discussions on companies that are looking for new products. We were supplied the contact information and a brief outline of what was needed to get their attention. Since we are getting more and more information on these and other potential companies, we need to compile a list and categorize them according to the type of products they desire. We are fortunate to have affiliation with the Inventor Groups of America who are diligently working to assemble the same. Our Council can expand on our "Circle of Trust" list that we have for companies that can make proto-types, do CAD work, etc. for inventors. We can compile an indepth list of all affiliates in the invention industry that are close to us and those out of state. It is clear to me that inventing has become a serious industry and there are many companies out there that can help the inventor proceed. Granted, there are scam industries out there waiting to prey on the novice inventor, but that is our job to keep that from happening. On the positive side, we can compile not only companies that will buy or license products, but those that will help inventors who are interested in running their own business based on their invention.

As a former Problem Solving instructor, I can tell you the best way to attack any issue is by brainstorming. An outline is compiled on just what information is needed and how it is to be categorized. The pros and cons are listed on each issue and, in our case, the potential outcome of getting involved with each particular company. Of course the logistics, ie company address, phone, contact, etc. will need to be listed. We have discussed these types of items from time to time in many of our meetings, but I feel we are at a point where a comprehensive dossier on companies would be a great asset to our membership.

Our Council has received accolades for developing a comprehensive and thorough Panel Review program for the novice inventor. We also offer our Circle of Trust for those who are ready for their next step. I hope we can develop a thorough dossier on companies that can complete the missions with our inventors.
