President's Note:

I have been monitoring Josh Malone and Randy Landreneau on their efforts to convince Congress that there is a major breakdown in patent legislation for the individual inventor. The biggest culprit is the Patent and Trademark Appeals Board who have the ability to cancel a patent that has already been issued. 84% of the 2,534 patents that have been fully reviewed by the Patent Trademark Appeals Board have been determined INVALID.

Randy and Josh have been successful in getting a Bill introduced in Congress, **H.R. 5478**, The Inventor Rights Act. What they need now is for inventors across America to contact their representatives and ask them to support or even co-sponsor the Bill so it will get passed. As you know, elected officials only step up when their constituency contacts them in large numbers. Now that Josh and Randy have gotten the ball rolling, let's not let their efforts be in vain. Thank you Randy and Josh.

Having this issue with patents in the back of my mind, I can't help but remind our members how important it is to have the ability to challenge patent infringement. Having said that, I feel the best way to protect your invention is to initially submit a Provisional Patent Application. If you feel your idea is good enough that a company may infringe on your patent then consider licensing or partnering with a firm that has the financial ability to submit your Utility Patent for you. Just the clout of a large firm may be enough to deter another company from going forward with patent infringement. The old saying, "You can't fight city hall" has unique ring here.

Moving on to another subject. For years our Council has offered the "10 Steps to Inventing" as part of our Panel Review. I have offered the one sheet guide to any inventor asking questions, since we individual inventors need to stick together. If you are interested in a re-fresher on the steps, I will be happy to go over them at one of our meetings. I also usually have a few copies available for members to review. It is wise as you continue in the process of developing your idea, or when you start a new invention, to "review your notes", to make sure you're not skipping a crucial step that can enhance or flag your idea. Let's always remind each other to work smart on our ideas.
